- As per the rule given in the Information brochure of Admission to Direct Second Year Diploma 2026-27 will be followed for conducting round at Institute Level for filling Vacant Seats after Non-Cap Counseling Round-I.
- Interested candidates are instructed to register their names along with registration form.
- Required Documents at the time of admission.
 - Printed copy of Final Merit Status for Admission mentioning Application ID and State General Merit Number.
 - All Original documents as listed in Receipt cum Acknowledgement issued by FC.
 - If Original documents are already submitted to any other institute, candidate has to produce certificate of document retention and attested Xerox copies of documents as listed in Receipt cum Acknowledgement issued by FC.
- Registered Candidates must report at/before scheduled time.

5. Candidates will be called as per the merit number. If the candidate is absent he/ she will lose the claim for admission. If the Candidate is present and seat is offered to the candidate as per merit, candidate has to pay entire admission fees as applicable online immediately. If the candidate fails to pay the entire fees, he/she will lose the claim, of admission to the offered seat and the same seat will be offered to the other candidate as per the merit. 6. If any candidate who is already admitted in any other institute and seeks admission in this counseling round, he/she has to cancel his/her earlier admission by paying cancellation fees. The cancelled seat of concerned institute will be made available to other candidates as per merit for admission during this counseling round.
